***Boise State University Football Ticket Giveaway—2025 Official Rules***

**No Purchase Necessary To Enter or Win.** Some restrictions apply. Void where prohibited. Mountain America Federal Credit Union “2025 Boise State University Football Ticket Giveaway” runs from 12:01 a.m. Mountain Daylight Time (MDT) on September 5, 2025, until 11:59 p.m. MDT on November 17, 2025. All entries must be received by 11:59 p.m. MDT on November 17, 2025. The winners will be drawn the week before each Boise State University home football game. Giveaway is sponsored by Mountain America Federal Credit Union (“Mountain America Credit Union”). To receive a hard copy of the rules, please send a self-addressed, stamped envelope to 2025 Boise State University Football Ticket Giveaway, c/o Mountain America, 9800 S. Monroe St., Sandy, UT 84070. Vermont residents may exclude return postage for Official Rules.

**Eligibility.** The Giveaway is open to legal residents of the United States of America (other than the states of Tennessee and California and recognized U.S. territories) who are eighteen (18) years of age or older as of the beginning of the Giveaway. Employees or agents of Mountain America Credit Union, and its subsidiaries, affiliated entities, or entity associated with the sponsorship or administration of the Giveaway (collectively, the “Sponsor”), as well as members of the same household of any such employee or agent, are not eligible to participate. The phrase “members of the same household” includes spouses, siblings, parents, children, grandparents, grandchildren, in-laws, and any other persons residing at the same household, whether or not related. No more than one (1) winner of Mountain America Credit Union sponsored Giveaways is allowed per household per calendar year. The Giveaway is void where prohibited by law.

**How To Enter.** A participant may earn one (1) entry/chance to win by completing the entry form by 11:59 p.m. MDT on November 17, 2025. To enter by mail, an entrant must send a self-addressed stamped envelope, along with his or her name, address, telephone number and email address to 2025 Boise State University Football Ticket Giveaway, c/o Mountain America, 9800 S. Monroe St., Sandy, UT 84070.

**Prizes and Odds.** One (1) winner will be selected at random for each Boise State University home football game. Selection of each winner will be the week prior to the Boise State University home football game for which the winner will receive tickets. Each winner will receive four (4) tickets to the game for which they are selected the winner. Game dates included in this giveaway are: Saturday, September 27, 2025; Saturday, October 11, 2025; Saturday, October 18, 2025; Saturday, November 1, 2025; and Saturday, November 22, 2025. Winners will be notified one (1) week before the home game to which they are receiving tickets. Actual odds of winning vary depending on the number of entrants. Each participant may only win one (1) set of four (4) tickets. Attempts made by the same individual to submit multiple entries by using multiple or false contact information will forfeit their entry and chance to win.

**Notification.** Winners will be notified by email (or telephone, where applicable) and winners may be required to sign an Affidavit of Eligibility and Liability Release, as well as a Publicity Release. In the event of noncompliance with these Official Rules, or if the prize is unclaimed or returned as undeliverable, the prize will be forfeited and awarded to an alternate winner determined by Mountain America.

Except where prohibited, all participants agree that: 1. Any and all disputes, claims, and causes of action arising out of or connected with this Giveaway or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the Utah State District Court in and for the Salt Lake County, state of Utah; 2. Any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Giveaway, but in no event, attorneys' fees; and 3. Under no circumstances will participants be permitted to obtain awards for, and participant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Giveaway, shall be governed by, and in accordance with, the laws of the state of Utah without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than the state of Utah.
